1. The Government of The United Republic of Tanzania has set aside funds for the operation of the Moshi Municipal Council during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover Eligible Payment under the contract for **Sub Contract Construction of Moshi International Bus Terminal.**
2. The Moshi Municipal Council now invites sealed Tenders from eligible National Contractors registered or capable of being registered in class I to carry out the **Sub contract Construction of Moshi International Bus Terminal.**

5. A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non refundable fee of TShs 100,000/= (One hundred thousand only).
6. All Tenders must be accompanied by unconditional bank guarantee of Tshs 100,000,000, in the format Provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.

All Tenders in one original plus three copies, properly filled in, and enclosed in plain envelopes must be delivered to the address of the office of The Secretary, Municipal Tender Board, Florida Road, Moshi at or before 10:00 hours local time on **Friday 2nd November, 2018**. Sub Construction For Construction of Moshi International Bus Terminal** NOT TO BE OPENED BEFORE 10:00 HOURS LOCAL TIME ON **Friday 2nd November, 2018**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the Municipal Hall, Florida Road, -Moshi.
